Bret mentioned a quote on tank inspections, which will be soon needed, which would cost a total of \$11,000. Motion to accept this quote and move forward with inspection made by Grier, second by Richard Jordan. Unanimous. Checked Danville meter reads and found that there was a problem with their meters and Danville was notified. There is a sewage block on Woodland Drive, Bret has contacted Stein regarding the issue. PRV Pit is getting stone and paving, on the 16th, Laurel Drive will be shut down

and the old pit will be filled in. On the Route 11 pumping line, there is hydrogen sulfide gas, which eats up the manholes, only solution is to have epoxy coated manholes. Can either be replaced or repaired, looking into prices and life spans of the options, to be checked with our engineer.
